1. RESOLUTION OF THE CABINET OF MINISTERS OF THE REPUBLIC OF AZERBAIJAN No 455

Amending Resolution No 6 of the Cabinet of Ministers of the Republic of Azerbaijan dated January 10, 1997 "On the approval of the Regulation on the "Permit System" regulating international road transport in the territory of the Republic of Azerbaijan"

Pursuant to the 8th paragraph of the Article 119 of the Constitution of the Republic of Azerbaijan, the Cabinet of Ministers of the Republic of Azerbaijan **decides**:

Part 7-1 with the following content shall be added to the "Regulation on the "Permit System" regulating international road transport in the territory of the Republic of Azerbaijan" approved by Resolution No. 6 dated January 10, 1997 of the Cabinet of Ministers of the Republic of Azerbaijan (Legislative Collection of the Republic of Azerbaijan, 2002, No. 3, Article 148; 2003, No. 8, Article 460; 2009, No. 1, Article 34; 2017, No. 2, Article 286; 2019, No. 1, Article 153, No. 12, Article 2094; 2021, No. 5, Article 533, No. 4, Article 390):

"7-1. "Permits" of the International Transport Forum provided for in Part 7 of this Regulation are issued by the Ministry of Digital Development and Transport of the Republic of Azerbaijan to the road carriers that meet the requirements of the "Quality Charter for International Road Haulage Operations under the ECMT Multilateral Quota system".

"7-1. Bu Əsasnamənin 7-ci hissəsində nəzərdə tutulmuş Beynəlxalq Nəqliyyat Forumunun "İcazə"ləri "Avropa Nəqliyyat Nazirləri Konfransının Çoxtərəfli Kvota Sistemi çərçivəsində həyata keçirilən daşımalar üçün Keyfiyyət Xartiyası"nın tələblərinə cavab verən operatorlara verilir.".

This list is developed on the basis of Charter requirements and circulated by the Agency of Land Transport in cooperation with ABADA, before and for the distribution of ECMT licences for 2023 and consequent years, subject to further amendments if required.

- 1. If the applicant is a legal entity, a copy of the extract from the state register of legal entities;
- 2. If the applicant is a natural person, a copy of the identity document;
- Copy of the certificate of registration of the applicant as a taxpayer;
- 4. If the applicant is a legal entity, information about the head (heads) of its management body (name, surname, father's name and position);
- 5. Information about the responsible person(s) (name, surname, patronymic and personal identification number);
- 6. Copy of the document confirming the identification of the responsible person (persons);
- 7. Vehicle registration certificate (technical passport) and certificate confirming environmental class
- 8. A copy of the document confirming the applicant's ownership, use or lease right on each of the motor vehicles;
- 9. A copy of the driver's license(s) and an extract from the centralized electronic information system of the Ministry of Labour and Social Protection of the Republic of Azerbaijan regarding the employment contract "notice of employment contract";
- 10. Compulsory insurance contract and international insurance contract concluded in relation to motor vehicles registered in the Republic of Azerbaijan Azerbaijan Green Card;
- 11. A copy of the compulsory insurance certificates for compulsory insurance of the motor vehicle driver against cases of loss of professional labour capacity as a result of industrial accidents and occupational diseases (series and number of compulsory insurance certificates concluded electronically);
- 12. A copy of the document confirming the existence of a maintenance station (area) for providing technical service to the motor vehicle (vehicles), maintaining and repairing it (them) or the contract (contracts) concluded with the person (persons) who will provide such services;
- 13. Certificate issued by the Ministry of Internal Affairs of the Republic of Azerbaijan on the absence of convictions of serious and (or) particularly serious crimes of the head (heads)/responsible person of the individual entrepreneur or the management body of the legal entity;

- 14. Absence of a court decision against the life and health of the head(s) of the management body of an individual entrepreneur or legal entity, responsible person(s), against property, in the field of economic activity, against the rules of traffic safety and the operation of vehicles, in connection with human trafficking and the illegal circulation of drugs, lack of conviction for serious and (or) particularly serious crimes against his interests, on deprivation of the right to hold a relevant position or engage in relevant activities:
- 15. A copy of the certificate of training or retraining according to the "Rule of Professional Competency Training and Retraining of Drivers Carrying Out International Passenger and Freight Transportation" Regarding the professional competence of the responsible person (persons), as well as the driver (drivers), approved by the Decision No. 247 of the Cabinet of Ministers of the Republic of Azerbaijan dated July 8, 2020.
- 16. Information about owning a carrier card used to download relevant information about the driver's work and rest periods from the tachograph and digital tachograph cards of motor vehicle with a corresponding category (subcategory).
- 17. Up to the date of submission of the application, financial statements and consolidated financial statements (with auditor's opinion attached) for the last accounting period approved by an external (independent) auditor, as well as a bank statement on the financial situation when owning, using or leasing only one motor vehicle, 9000 (nine thousand) euros, when having two or more motor vehicles, 5000 (five thousand) euros for each additional motor vehicle to assets (cash, deposits) and other assets);
- 18. The certificate of roadworthiness test for a trailer and motor vehicle as well as certificates of emissions and noise of exhaust gases emitted into the environment and safety requirements.
